

Minnesota Kev Saib Xyuas & Kev Tswj Saib Xyuas

Daim ntawv kos tawm rau qhov kev xaus

1. NPAJ

Tham nrog tus neeg uas tau qhov kev saib xyuas txog qhov kev npaj: Qhov lawv yuav cia siab tias yuav txawv/zoo dua qhov tsis muaj tus saib xyuas /tus tswj sai xyuas? Qhov lawv ntshai yog dabtsi?

Yaum cov neeg txheeb los pab tus neeg no xws li nws tsev neeg, cov social worker, cov neeg ua haujlwm ua niaj hnub pab nws, lossis cov kws kho mob kom qhia txog lawv txojkev xav txog qhovv kev pab txhawb yam tus neeg no xav tau.

Xav txog kev siv ib yam cuab yeej xws li Brainstorming Guide to Supported Decision-Making los tham txog yam uas tus neeg xav tau kev pab lossis qhov twg kev txhawb nqa yuav txuas ntxiv mus tom qab kev saib xyuas/kev saib xyuas xaus (raug tshem tawm) lossis hloov pauv (raug hloov kho)

Saib cov ntaub ntawv lossis cov cuab yeej uas yuav siv tau los txhawb kev txiav txim siab tom qab qhov kev saib xyuas xaus xws li:

- Dim Ntawv Cawm Siav (Health Care Directive)
- Power of Attorney
- Daim Ntawv Tso Cai Rub Ntaub Ntawv (Releases of Information)
- Supported Decision Making Agreement
- Authorized Representative (DHS/MA/Waiver)

Saib cov ntaub ntawv lossis cov cuab yeej uas yuav siv tau los txhawb kev txiav txim siab tom qab qhov kev tswj saib xyuas xaus xws li:

- Power of Attorney
- Representative Payee ntawm Social Security
- Tuam Txhab Khaws Nyiaj tej cuab yeej
- ABLE Account, Special Needs Trust, lossis lwm cov nyiaj txiag cov cuab yeej
- Kev pab tsis raws cai nrog kev npaj cov ntaub ntawv thiab muab qhov tseem ceeb ntawm kev siv nyiaj ua ntej.

2. DAIM NTAWV TSIS TXAUS SIAB

Xaiv seb xum koom nrog ib tug kws li choj lossis ua cov ntaub ntawv tsis txaus siab es tsis siv tus kws li choj hu ua ("pro se"). *Ntawv ceev tseg: Persons Subject to Guardianship lossis Conservatorship muaj txojcai los muaj ib tug kws li choj sawvcev rau lawv thaum mus hais txog kev tsis txaus siab rau hauv tsev hais plaub.*

Txawm tias txojcai tsis kom muajlos, yog saws tau ib cos lus povthawj ntawm cov kws li txhawj (professionals) li cov kws kho mob los yuav txhawb qhov kev xaus zoo heev, lossis ib tsab ntawv los ntawm ib tug kws li txawj uas paub tus neeg zoo.

Minnesota Kev Saib Xyuas & Kev Tswj Saib Xyuas

Daim ntawv kos tawm rau qhov kev xaus

Txhawb tus neeg kom qhia meej txog qhov nws xav tau. Lawv yuav tsum qhia nws siab nyiam thaum nrog tus tuam tom tsev hais plaub lossis lawv tus kws li choj tabsi tej zaum yuav tau muaj kev pab sawv cev rau lawv tus kheej.

Npaj rau lub rooj hais plaub. Koj yuav tau phia yog vim li cas thiaj li tsis xav tau kev saib xyuas/kev tswj kev saib xyuas thiab qhia lwm yam kev pab uas tus neeg muaj thiab cov kev npaj rau tus neeg thaum muab qhov kev saib xyuas/kev tswj saib xyuas xaus. Tej zaum lawv yuav nug koj kom koj piav qhov txawv hauv tus neeg lub neeg tamsim no thiab thaum tseem tau qhov kev saib xyuas/qhov kev tswj saib xyuas xub muab tso chaw los pab.

3. TOM QAB-HLOOV KHO/XAUS

Ua cov ntaub ntawv kom tiav uas yog:

- Daim Ntawv Cawm Siav (A Health Care Directive)
- Daim Ntawv Tso Cai Rub Ntaub Ntawv los ntawm cov chaw kuaj mob, cov social service, thiab tsev kawm ntawv
- Supported Decision Making Agreement
- Power of Attorney

Muab cov ntaub ntawv no daim qauv rau cov neeg tseeb ceeb lossis cov koomhaum thiab rau cov koj taws lossis muj npe ceev rau hauv cov ntaub ntawv.

Qhia rau cov uas muab kev pav thiab rau lwm tus uas paub tias qhov kev siab xyuas/qhov kev tswj saib xyuas twb tau xaus lawm.

Qhia cov neeg pab cov kev tivtas rau tus neeg tus kws kho mob yog tiias tsis tau muaj nyob rau cov ntaub ntawv (xws li daim Health Care Directive, Release of Information, Supported Decision Making Agreement, etc.).
